Regional Carriers grew surplus 12.6%

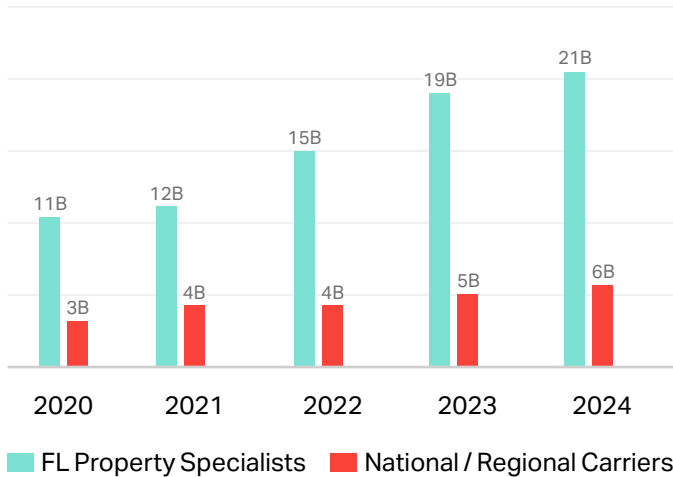

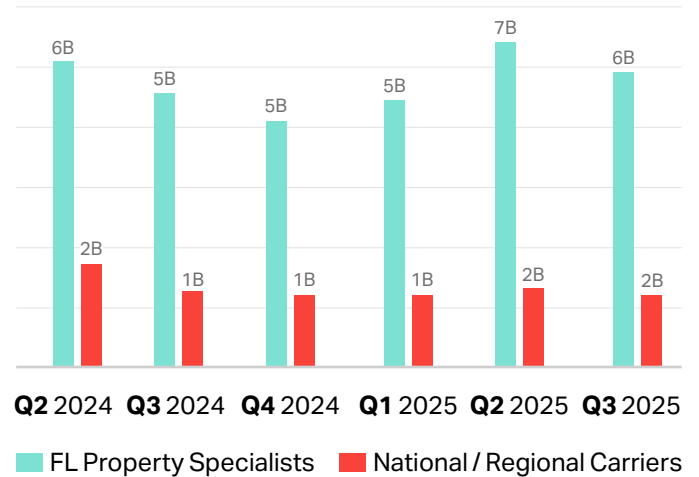

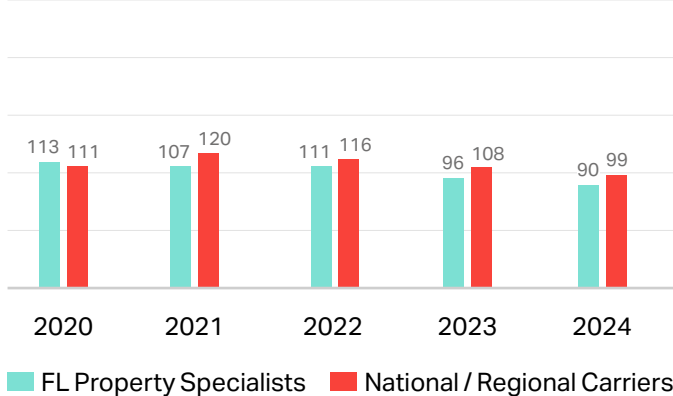
Last 5 years DPW



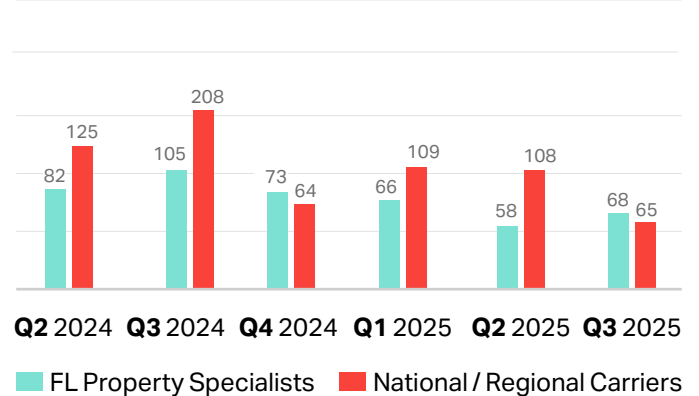
Last 6 quarters DPW



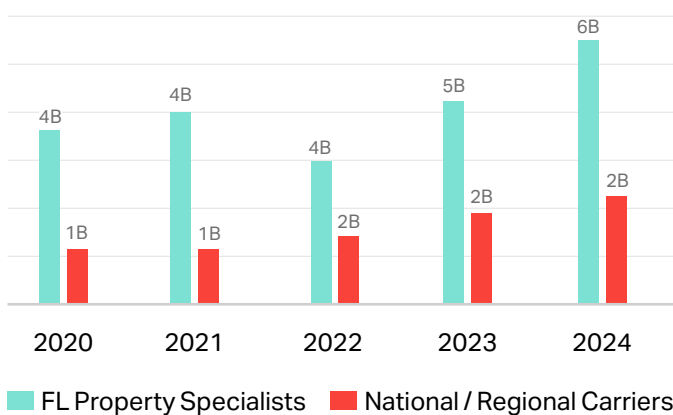
Last 5 years net combined ratio
Weighted Average



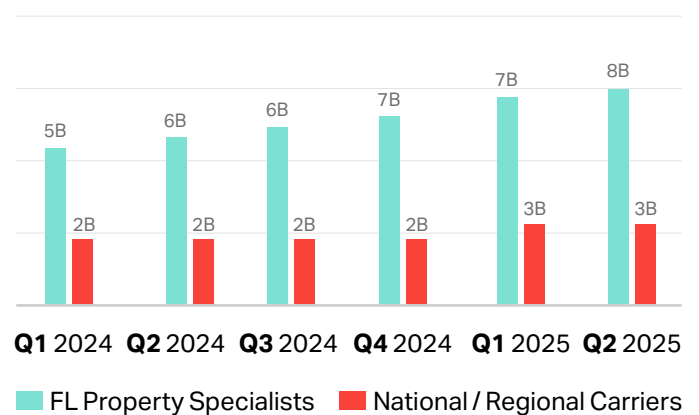
Last 6 quarters net combined ratio
